This led to a discussion of future Board activity, which primarily centers on the federal re-packing effort, and progress with the Community Channel planning. Right now, the re-packing auction is being conducted, but the number of channels to be restructured is large, so that the auction may not be effectively concluded this time. Also, there appear to be political considerations with this year's fall election. So Board members may feel that they are not free to go on to other things with MVTVD facing such upheaval. More discussion is expected.
